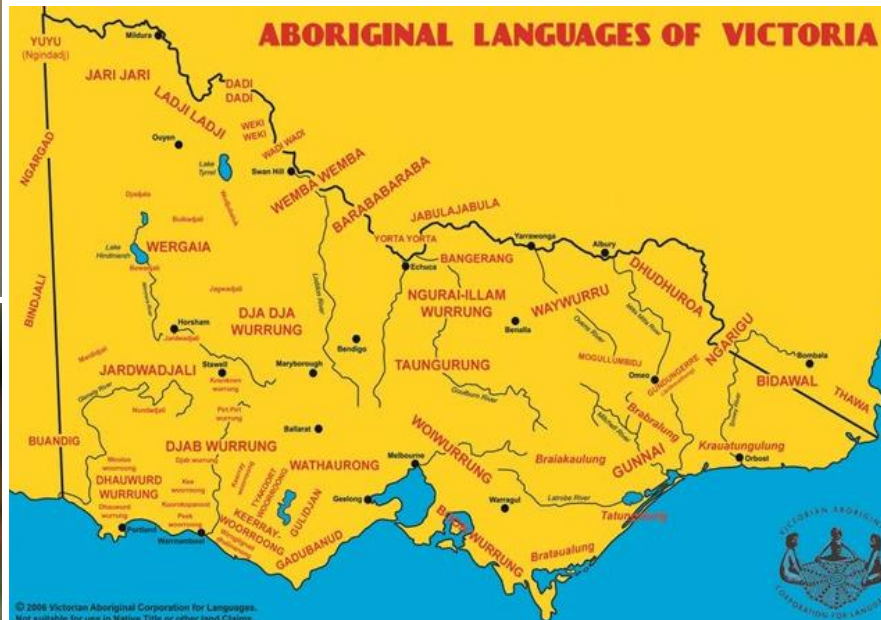
We West Papuans acknowledge the Kulin Nation Alliance of five Indigenous tribes (distinct language groups): Woiwurrung, Wathaurong, Taungurong, Dja Dja Wurrung, and the Boon Wurrung.

We especially acknowledge the Wurrundjeri, a clan of the Woiwurrung, who own the land beneath the city of Melbourne. Wurrundjeri land extends north of the Great Dividing Range, east to Mt Baw Baw, west to Werribee, and south to Mordialloc Creek.



New Holland Daisy: listed on 2014 *Advisory list of rare or threatened plants in Victoria*

Docklands for the Wurrundjeri was a vast wetlands eco-system used for hunting and gathering food and medicines, for making canoes and tools (spears and shields) and utensils (baskets and bowls, roofing and blankets), and for painting.



At the time of European contact, there were 350–750 distinct Aboriginal languages; about thirty-nine in 'Victoria'. Today, all except twenty are highly endangered. Of those surviving just ten percent are being learned by children.

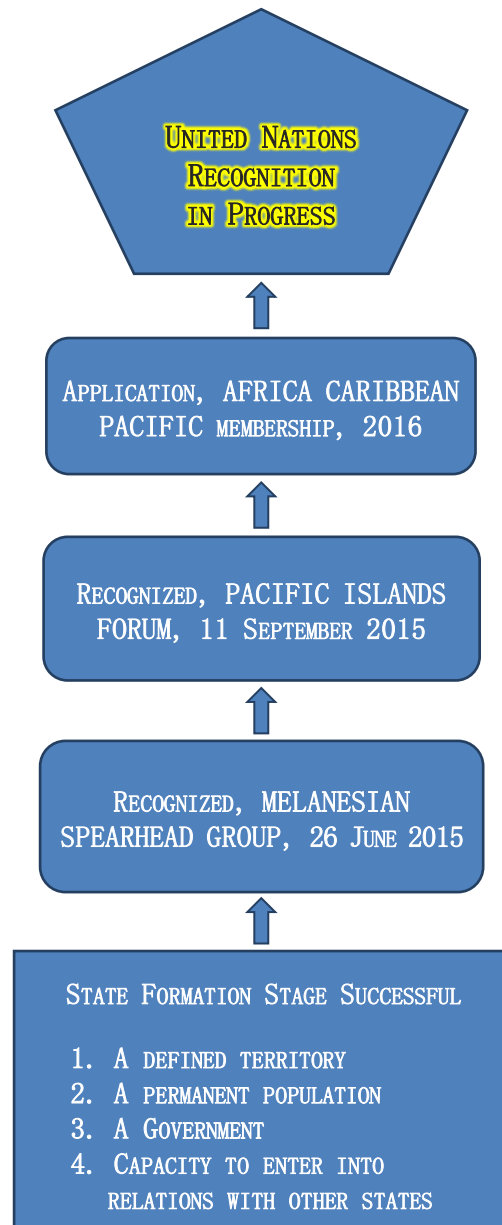

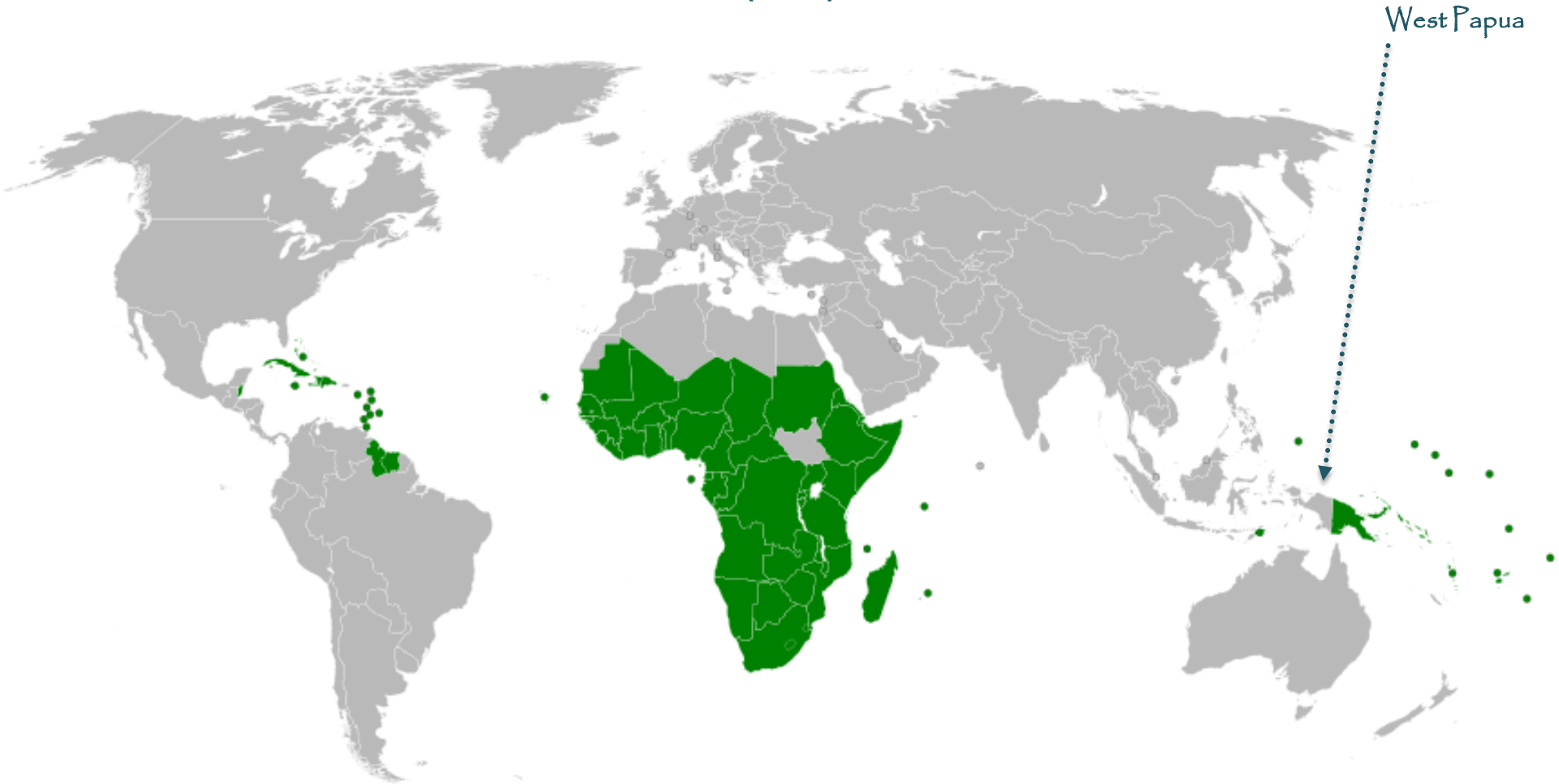

URGENT - NEW SHOCKING PHOTO OF 20 YEAR OLD WEST PAPUAN STUDENT TORTURED BY INDONESIAN POLICE

We have received urgent reports that 20 year old West Papuan student Obi Kogoya was brutally tortured yesterday 15th July during his arrest after West Papuans in Yogyakarta demonstrated for full MSG membership. The West Papuan student dormitory has been under siege by the Indonesian police for the last 2 days since the peaceful MSG demonstration.

The Indonesian Security Minister Luhut Panjaitan, (who once served in East Timor) described the siege as "normal". The Yogyakarta City Police Chief Sr. Tommy Wibisono said "If they are demanding Independence, there are criminal rules".

Chairman of the Student Union and West Papuan Students, Aris Yeimo, told BBC Indonesia police blocked the front door and the back door of the hostel since morning, so about 60-70 people inside cannot get out. We need a royal commission

As a soldier and a senior military intelligence figure, Lance Collins has served his country faithfully for more than two decades. His loyalty and commitment to reporting the truth has cost him dearly. It's now time for that debt to be repaid.

Nothing short of a royal commission will fully resolve the question marks hanging over the quality of Australia's intelligence services, much less the treatment handed out to Collins in the past few years.

The Bulletin has chosen to publish the restricted report by retired naval barrister Captain Martin Toohy in the public interest. We believe that in a climate where national security remains the highest priority for the federal government, the disturbing findings of the Toohy inquiry raise issues that should be debated and scrutinised by all Australians.

While the Toohy report principally examines the events surrounding Australia's deployment of troops to East Timor and the subsequent shabby treatment of Collins by the defence establishment, it raises alarming questions about the manner in which this country receives and interprets its intelligence.

If, as Toohy has found, a "pro-Jakarta" lobby exists within defence intelligence and shapes its reports to the government based on this bias, how certain can we be that the rest of the intelligence the government relies upon is also not subject to similar biases? A pattern is already evident. The so-called intelligence evidence relied upon by the United States, the United Kingdom and Australia as justification for the war in Iraq lies in shreds. And several other regional incidents in recent years – from the Bali bombing to the Fiji coups – were never in the sights of our intelligence agencies.

John Howard has staked his personal future, one that of his government, on the promise of protecting Australia's national security. Without a royal commission, that promise will sound hollow. And its echoes will be heard for years to come.

Collins' assessments proved accurate." Lewincaup told the Toohy inquiry that he categorically rejected any interpretation that DIO was influenced by a political agenda.

The Defence Department had appointed Toohy, a member of its approved list of investigating barristers, to inquire into a complaint by Collins that he had been treated unjustly by having his name placed wrongly on an Australian Federal Police warrant following leaks of sensitive information over East Timor, some of which had appeared in *The Bulletin*. All key parties accept that Collins' name was placed wrongly on the warrant, and that he had never leaked any information. But Collins decided to pursue the matter through the army's redress of grievance (ROG) procedures.

The Toohy report notes: "I find as a fact that Lt Col Collins, arguably the army's most skilled intelligence analyst, engaged in organisational, albeit constructive and accurate, criticism of Defence and associated intelligence organisations, with particular emphasis on DIO and DEAT but in so doing at times exceeded his remit of re-examining his assessments to operational and tactical areas."

One of Collins' claims is that a senior military figure said words to him to the effect: "We have a plan with the Indonesians to keep everyone else out of East Timor."

The affair surrounding Collins' determined pursuit for justice – and the damning indict-

ment of Australia's security and defence organisations that followed and supports his claims – provides the Australian public with a rare view into the secretive world of military intelligence.

What it reveals is an atmosphere of political intrigue, personal character assassination and growing evidence of an intelligence bureaucracy more intent on serving its political masters than fulfilling its duty to protect the Australian national interest.

Lance Collins was the all-Australian boy who became a shining light of the Australian army. A farm boy who grew up in Victoria and decided to pursue a military career, he had risen quickly through the ranks, attaining the status of major within seven years. In 1998, he was deployed to Kuwait on a prestigious assignment to work on the intelligence staff of the US-led coalition taskforce.

So well regarded was he that when another decorated army figure, Peter Cosgrove, was asked by John Howard to lead a mission of 4500 Australian troops into East Timor in September, 1999, Cosgrove turned to Collins to be his intelligence commander.

Interfet was the largest deployment of Australian soldiers overseas since the Vietnam War. In a dangerously-charged political environment that had seen a deterioration in the relationship between Australia and its
